## **Executive Summary**

The activity of the Centre for Continuous Electoral Training for 2021, carried out based on the annual activity plan, approved by the Decision of the Central Electoral Commission No 4639 of 9 February 2021, was focused on achieving the objectives of the strategic development directions of the institution, as well as on conducting training for electoral stakeholders during the elections.

The following electoral events took place during 2021:

- Early Parliamentary Elections of 11 July 2021;
- New local elections in 15 municipalities on 21 November 2021.

The year 2021, like the previous one, was marked by the COVID-19 pandemic, i.e. it was necessary to change the format for a number of planned events.

CICDE's efforts have been directed towards training electoral officials and other key electoral stakeholders for the elections, strengthening the capacity to deliver online training, conducting civic education and outreach activities targeting voters and other electoral stakeholders, and researching topics of interest to the electoral field.

In 2021, CICDE conducted 281 training seminars with physical attendance, 66 webinars, 11 videoconferences for 18 different categories of beneficiaries: electoral officials, observers, SVR registrars, judges, police officers, representatives with advisory voting rights, teachers, librarians, etc. A total of 13,363 people were trained. Despite all efforts, on average just over 30% of the members of each electoral body have been trained for the 2021 elections. The lack of mandatory training for electoral officials increases the risk of errors and inconsistent application of electoral legislation on the one hand, and leads to poor cost-effective planning of financial, time and human resources on the other. In this regard, it is necessary to make legislative amendments that would regulate the training as a precondition for being included in the electoral body and creating permanent regional centres/branches of CEC (objective set in 2020-2023 CEC Strategic Plan). It would also be appropriate that a part of the state subsidies received by political parties is directed, on a mandatory basis, to electoral training of party members and supporters through the CICDE.

Outside the election period, CICDE conducted a series of civic and electoral education activities aimed at improving the level of knowledge of the electoral process. 36,500 people of different ages benefited directly from civic education and electoral training activities.

During 2021, around 140 million people viewed and interacted with the products developed by the CICDE and posted on its official website, YouTube and social media. The 10th anniversary of the foundation of the CICDE served as the theme for the campaign to promote the achievements of the institution.

On the research component, during the reporting period, CICDE continued its efforts in developing the research grant program, publishing the electoral analysis, theory and research magazine 'Digest Electoral', policy briefs, analytical notes and organising live events on Facebook with experts from different countries. The CICDE also developed the methodological framework for the provision of electoral advisory services (activity carried over from 2020) and held its first scientific conference with international participation.

Of the 40 activities included in the CICDE Annual Activity Plan for 2021, 36 were fully implemented (90.0%), 3 were partially implemented (7.55%) and 1 (2.5%) was not implemented and is to be carried over to 2022.



Of the total current expenditure for the maintenance of the Centre for Electoral Training, 42.37% is expenditure for the remuneration of staff, for the payment of mandatory state social security contributions payable by the employer. Thus, the amount of MDL 734,949.04 was intended for the remuneration of work, the amount of MDL 243,886.32 – for the payment of mandatory state social security contributions. The execution in this respect is 90.2%.

The amount of expenditure for services is MDL 999,662.43, which is 42.49% of the total expenditure under 'Current Expenditure'. Under this category, expenditure for information and telecommunication services amounted to MDL 103,198.58, which includes payments for telephone and internet services, technical servicing and maintenance services, public key certification services for electronic signature, maintenance services for the 'Activity Report' module, installation, administration, configuration of nomenclatures and maintenance of 1C IS, Zoom subscription services. Under the category 'Transport Services', the amount of MDL 52,265.57 comprises the expenditure for car insurance and testing, as well as the toll for the use of roads for the car owned by CICDE.

Under the budget line 'Current Repair Services', the amount of MDL 23,530.00 includes the expenditure for computer and car repair services, as well as furniture repair services.

Under the budget line 'In-service Training', the amount of MDL 16,600.00 includes the costs for the training of CICDE employees.

For business trips abroad, the amount of MDL 79,985.82 includes payment of daily allowance and purchase of plane tickets.

Under the heading 'Services not assigned to other categories', the amount of MDL 698,578.46 includes the cost of cleaning services, technical assistance services, translation services (RO-ENG/ENG-RO, RO-RU/RU-RO), design, drafting, training and coordination services for training seminars, as well as the payment of mandatory state social security contributions payable by the employer related to these contracts.

During the year, funds amounting to MDL 273,160.52 were spent on the purchase of reserves of circulating assets. This category reflect the expenditures for the procurement of fuel in the amount of MDL 7,000.00. The funds allocated in 2021 for the purchase of household materials (including disinfectants and masks) and office supplies amounted to MDL 45,210.00, and MDL 199,250.52 were used for printing teaching materials, purchasing board games and drinking water.

The public procurement of goods and services from the CICDE's financial resources was carried out in accordance with the procurement plan, approved by the CICDE Director on 6 January 2021 and subsequently amended on 3 March and 19 August, with the arrival of additional financial resources in the institution's budget for the conduct of new local elections (activity 00063) and the implementation of projects funded from external sources (activity 70340, 70203).

The last modification in the 2021 procurement plan was made on 24 November, with the reallocation of financial sources from one expenditure item to another.

For the procurement of goods and services for the organisation and conduct of activities in the context of the early parliamentary elections of 11 July 2021, the corresponding procurement plan was approved on 20 May.

Most of the public procurements made were of low value, based on the Regulation on Low-Value Public Procurement No 665 of 27.05.2017.

Pursuant to Article 5(r), of Law No. 131 of 03.07.2015 on public procurement (exception to the application of the provisions of the said law), a public procurement procedure was carried out for the purchase of printing goods (teaching materials for training seminars for electoral officials and other people responsible for the organisation and conduct of elections).

During 2021, 196 contracts for the purchase of goods and services were concluded with both legal entities and individuals. The concluded contacts were registered with the State Treasury within the deadline set by the law.
